Youth gangs make up less than 1 percent of the US population



They commit 11% of total crime in the US. (The United States Department of Justice, 2020)

Gang-involved youth have violent crime rate three-times higher than non-gang delinquents. (The United States Department of Justice, 2020)

Typical initiation involves being beaten by current gang members. (Bolden, 2013)






Intergang wars can be sparked by random encounters and kept alive


