**Position Description:** The Department of Criminal Justice is seeking to fill **one full-time tenured/tenure-track position beginning Fall 2020** at the **Associate/Assistant Professor** level. Responsibilities include conducting and publishing scholarly research, seeking extramural funding, teaching face-to-face and online courses, and service to the department, university and profession.

**About UTEP:** The University of Texas at El Paso is an R1, Community Engaged research university in the U.S.-Mexico border region, in a city of over 700,000 people. UTEP faculty are nationally recognized for their commitment to student success, teaching, and research. UTEP enrolls more than 25,000 students, of whom nearly 80 percent are Latino. In providing equal access to higher education and social mobility for many first generation students, UTEP comprises 8 academic colleges and schools, and a graduate school. The Department of CJ offers an on-campus B.A. in Criminal Justice, an equivalent 100% online B.A., and an M.S. in Criminology and Criminal Justice. The CJ Department has developed agency relationships to provide faculty with access to agency-based research opportunities.

**Required Qualifications for Associate:** Applicants must have a Ph.D. in Criminal Justice, Criminology or closely related field and have 5 or more years post Ph.D. teaching experience, and a scholarly record of research publications and grant activity. Applicants with only a J.D., Psy.D., or Ed.D. will *not* be considered.

**Required Qualifications for Assistant:** Applicants must have a Ph.D. in Criminal Justice, Criminology or closely related field. ABD applicants will be considered if doctorate will be in hand by Fall 2020. Active research agenda and scholarly research publications required. Applicants with only a J.D., Psy.D., or Ed.D. will *not* be considered.

**Preferred Areas:** All research areas of criminal justice, criminology, and social justice as it relates to CJ will be considered. Teaching areas are open, but preferred teaching areas include **criminal justice policy/systems or research methods/program evaluation.**

**Application Instructions and Contact Information:** Applicants must electronically submit: (1) letter of interest that specifies the rank of the position sought, and includes teaching areas and research expertise, (2) curriculum vita, (3) one publication, and (4) names and full contact information of three references that we may contact.
