The Department of Criminology and Criminal Justice within the Steven J. Green School of International and Public Affairs invites applications for a Postdoctoral Fellow position. This is a fixed term (one year, with the possibility for a renewal for a second year). Preference will be given to applicants who specialize in prosecution/sentencing and racial disparities. Racial and ethnic minorities are strongly encouraged to apply. Periodic travel to prosecutorial jurisdictions both within and outside of Florida will be required. The position will provide opportunities for producing cutting-edge, policy-relevant research and academic publications. The Department of Criminology and Criminal Justice is located within FIU's Steven J. Salary will be commensurate with education and experience. The preferred start date for the position is November 4, 2019 but is negotiable. Review of applications will begin August 5th and continue until the position is filled.
