CCJS 105: Introduction to Criminology Fall 2022 semester This course will provide a general introduction to the study of crime. We will cover correlates of crime, crime measurement, crime trends, criminological theory from the Enlightenment era to recent decades, and how theory relates to criminal justice policy and crime prevention. TA duties include lesson planning and leading four weekly discussion sections for 15 weeks, grading papers, inputting grades, proctoring exams, holding office hours and meetings for students, answering emails, reporting back to advising faculty, and serving as a liaison between students and lecturer.

CRIM/WMNST 197: Domestic Violence in the LGBT Community Spring 2022 semester This class explores trends and statistics regarding; societal implications of; and implicit personal biases about; domestic and intimate partner violence within the LGBTQ+ community. Students will use a feminist lens to understand statistics and personal reports of violence within the LGBTQ+ community, and why survivors make the decisions they do. Students will explore institutional oppression and the importance of public representation of the issue, and how these things present themselves as barriers to help-seeking. Students will also investigate the systems with which survivors must interact in order to obtain help. Class goals will be achieved through readings, digital discussion posts, and in-class participation.
