Course Description

A contemporary analysis of ethics within the criminal justice field. Students will be introduced to the logic, philosophy and development of ethics throughout history leading into the criminal justice profession. The foundations of ethical thinking will be explored including moral decision making, moral theory, consequentialism, regularianism, deontology, and virtue theory. A review of ethics as it pertains to the criminal justice field will be covered with emphasis on law, justice and rights. Analysis of fictional and non-fictional cases will be reviewed and discussed as well as current ethical issues facing the criminal justice field.

Core Learning Outcomes

- 1. Demonstrate an understanding of the various ethical theories.
- 2. Identify and differentiate between the ethical theories as they are applied to case studies and scenarios.
- 3. Identify the impacts of ethical decisions in the criminal justice field.
- 4. Demonstrate an understanding of how the students themselves make moral and ethical decisions to strengthen their abilities to make strong moral and ethical decisions.
- 5. Identify the correlation between solid moral and ethical decision making and leadership.

Instructional Methods

Class discussion, group activities, videos, homework and class assignments, guest speakers, tests/quizzes, lecture, and a final paper/project.
