COURSE MEETING TIME FOR LECTURES

This class will be held face to face and will meet on Mondays and Wednesdays from 4:30 pm (EST) to 5:45 pm (EST) in room 1100 of Tawes Fine Arts Building.

COURSE DESCRIPTION

This course will provide a general introduction to the study of crime. We will cover correlates of crime, crime measurement, crime trends, criminological theory from the Enlightenment era to modern times, and how theory relates to criminal justice policy and crime prevention.

COURSE LEARNING OBJECTIVES

After the completion of the course, students will be able to:

- 1. Demonstrate an understanding of the American criminal justice system
- 2. Demonstrate an understanding of the major theories used to explain criminal and delinquent behavior.
- 3. Examine how crime and delinquency are defined and measured in America.
- 4. Identify specific issues of crime including offender reentry and technology and crime.
- 5. Understand the different types of crime

EXAMS

You will have a total of three multiple choice exams, which will (all together) account for a total of 60% of your overall grade in this course. Exams will be fifty minutes long, and will feature content from the lectures, class discussions, course readings, and any other activities that are assigned. All content mentioned in lectures or that appears on the PowerPoint slides are fair game for quizzes and exams, so take notes accordingly. Exams will **not** be cumulative. Exams will not be curved in the course. Exams and all assignments are considered to be Major Scheduled Graded Events and therefore the University medical excuse policy which allows one student signed honor statement attesting to illness does **not** apply to them. All students should arrive on time to exams with their University ID, at least one pencil, and an eraser. Students arriving after the first student has completed the exam will not be allowed to take the exam and will receive a zero. Please plan accordingly, as I will not make any exceptions to this policy.

QUIZZES

You will have a total of four multiple choice quizzes, which will (all together) account for a total of 20% of your overall grade. Quizzes will be administered via pencil and paper, are closed note, and will be completed during lecture time, at the beginning of class. Each quiz will consist of 10 questions and you can expect multiple choice, true/false, fill-in-the-blank, and short answer questions on the quiz. You will have 25 minutes to complete each quiz. Content eligible to appear on quizzes includes content from lectures, classroom discussions, course readings, and any other activities that are assigned. All content mentioned in lectures or that appears on the PowerPoint slides are fair games for quizzes and exams, so take notes accordingly. Students arriving after the first student has completed the quiz and handed it in will not be allowed to take the quiz and will consequently receive a zero. Please plan accordingly, as I will not make any exceptions to this policy.

EXTRA CREDIT

The class before the exam will incorporate extra credit activities that can only benefit students.

These activities will help prepare students for each exam and each point the student earns on the assignment will be added to each following exam. If you are absent on the day of an extra credit assignment, you will forfeit the opportunity to earn those points and there will be NO makeup assignments (even for excused absences).

PARTICIPATION

In-class participation is essential to this course and accounts for 20% of your overall grade. Your in-class participation grade will be the combination of two elements: contribution to the class discussion and discussion questions and comments in the class discussion forum. Students are expected to post discussion questions/comments demonstrating that they have critically thought about the assigned reading materials (i.e., textbook chapter).

MAKEUP POLICY

With COVID-19 still present, I am going to be flexible if life events make it difficult to keep up with class. I want to be there to support you during this difficult time, though, to do this, I need to know about a problem when it starts, not afterwards. Please let me know of the issue sooner rather than later (and please only tell me what you are comfortable with sharing). I know some issues occur unexpectedly so please don't hesitate to reach out regardless but, generally, I am in a much better position to help and make accommodations if you tell me when the problem arises.

Exams/Quizzes: Makeup exams and quizzes will only be given in cases of excused absences which always require prior written notice to the start of the exam/quiz and documentation to determine if your absence was excused. If you miss an exam/quiz and notify Ms. Romm after the start of the exam/quiz, you will not be able to reschedule the exam/quiz. Please contact Ms. Romm immediately (before the start of the exam/quiz) to let her know if you will not make the exam/quiz so we can begin the process of rescheduling while you gather documentation. All makeup exams/quizzes must be completed as soon as you return but no later than one week of the missed exam/quiz, per the instructor's availability. Failure to adhere to these policies will result in a grade of zero for the exam/quiz.

Discussion: Makeup discussion posts will only be given in cases of excused absences which always require prior to the due date, as well as official documentation. All makeup discussion posts for a missed discussion, due to an excused absence, must be completed before the next discussion due date. Failure to adhere to these policies will result in a grade of zero for the missed assignment.

GRADE DISPUTES

If you have questions or concerns about your grade on any assignment and believe I should

review it, you must submit a written request over email that describes your concern in detail. This request must be submitted within one week after grades for the relevant assignment have been posted.

CLASSROOM CODE OF CONDUCT

As a department and university, we expect the faculty and students to be prepared for class and to be actively engaged in the classroom activities. Unfortunately, disruptive behaviors in the classroom cheat other students of opportunities to learn. DISABILITY SUPPORT

Students who are registered with the Accessibility and Disability Service (ADS) Office and provide required ADS documentation will be accommodated in the classroom. After receiving an Accommodations Letter from ADS, you are expected to meet with each course instructor, in person, to provide them with a copy of the Accommodations Letter and to obtain their signature on the Acknowledgement of Student Request form. The Accommodations Letter must be presented to me no later than September 12th. ADS students who are requesting to take their exams at the ADS Testing Office need to provide me with a testing form online at least three business days prior to each exam or will have to take the exam with the rest of the class. Saturday and Sunday are not business days. The student is expected to take the exam at the same time as the rest of the class, unless other accommodations have been approved by the instructor. I am not able to accommodate students who are not registered with ADS.

If these devices are seen and/or used during an exam, the exam will be collected from you, and you will no longer be allowed to continue taking the exam. The exam score will be noted as zero and you will be referred to the Student Honor Council. In addition, you are not allowed to record the lectures (neither audio nor video recording) or take pictures of any of the course material. The only exception to the use of technology policy is if a student has required documented accommodations through ADS and has provided me with this documentation before the second week of class. Computers and ipads can be utilized to take notes in class.
