Course Description

This course provides knowledge about the nature, causes, and societal responses to child abuse. The course is intended to discuss child abuse from the perspective of multiple disciplines, including social science and public policy. The specific topics of physical, psychological, and sexual abuse, internet exploitation, and child pornography will be analyzed in depth.

Course Objectives

- 1. Discuss child abuse in its historical, legal, economic, political and social contexts.
- 2. Identify the scope of the problem, different forms of child abuse in the United States and the different interventions involved at all levels.
- Discuss the dynamics of child abuse in order to understand the relationship between offenders, victims, and observers.
- 4. Examine the roles of government, the community and individual actors in addressing the problem.
- 5. Compile strategies that have proven effective in intervention and prevention.

Course Requirements and Evaluation

This is an upper-level course. A typical week in this course will involve the student completing the assigned readings, completing a written assignment, and completing an asynchronous discussion (discussion forum). On the fifth, tenth, and last week of the course, students will complete an online, multiple-choice quiz. Those readings which are not chapters in your text will be provided by the instructor.

The class will meet each Wednesday from 6:30pm to 9:00pm.

Quizzes: There are three online, multiple choice quizzes in this course. They are scheduled in the syllabus. The quizzes will be available on quiz day (Wednesday of that week EXCEPT for the last quiz) from 12:00pm to 11:59pm. You may complete the quiz any time during the period they are open. You are expected to complete the quizzes independently.

Reading Assignments: Each student is responsible for reading assignments as outlined below as well as other readings posted on the ELMS website. All students should be fully prepared to participate in asynchronous (online) discussions.

Participation in Weekly Discussions: Weekly discussions begin on Monday of each week and all original posts are due by Wednesday evening at 11:59pm of that week; responses are due by Sunday night at 11:59pm of the same week. I expect students to participate in weekly discussions and be responsive to posts by peers. Each student should provide an original post based on materials in the course. Students are encouraged to locate and cite sources and news articles outside of the course on their own. Each student should respond to at least two of their peers' posts in a way which is meaningful, respectful, and expansive of the conversation. "I agree" is not sufficient. For example, if a student cites a news article about child abuse victims being treated at offenders instead of victims, a response might include a discussion of another unique article, or a related article or theory pertinent to the topic. Original posts should cite sources in APA format. Think of your original post to the discussion as a "mini-paper."

Written Assignments: Students will individually write a review of one of several articles in the course article library. Your review should incorporate material from at least two of the other required readings and/or may include additional scholarly literature or government reports. You are expected to summarize the article and discuss its implications for child abuse intervention/policy. Students will also conduct guided independent research in certain areas of child abuse throughout the course. The topics may be a particular population, component of the criminal justice system, policy, etc. All submissions should be 2 or more pages double spaced, APA format. Due dates and specific assignment parameters will be provided in Canvas.

Course Policies

Attendance and Make-Up Policy

Opportunities to make-up missed in-class work will only be given in cases of excused absences and official documentation is required.
